### DECISION

#### **K.M. and Others v. Greece**

(no. 14651/25)

*Request for interim measures lodged on 16 May 2025*

The European Court of Human Rights (P. Roosma, the duty judge) has, on 19 May 2025, examined the request.

The Court decides, in the interests of the parties and the proper conduct of the proceedings before it, to indicate to the Government of Greece, under Rule 39 of the Rules of Court, i) to provide the applicants with appropriate reception conditions, including adequate food and water, new and clean clothing and bed linen, cleaning and hygiene products, ii) to provide them with appropriate medical and psychological care, and iii) to ensure their speedy relocation to a shelter for unaccompanied minors or to a proper accommodation facility according to the procedures prescribed by national law, until further notice.

The Court decides to request both parties, under Rule 54 § 2 (a), to submit information concerning the applicants' current situation.

The Court decides to give priority to the application under Rule 41.

The Court decides, under Rule 47 § 4, not to disclose the applicants' identity to the public. In all of the Court's public documents the applicants will accordingly be referred to using the letters of the alphabet shown in the appendix.

K.M. AND OTHERS v. GREECE DECISION

Any documents deposited with the Registry in which their names appear or which could otherwise easily lead to their identification should not be made accessible to the public (Rule 33 § 1) and shall remain confidential.
